1. Why are you running? Why should we vote for you?

I chose to run for the DCCC because of the desire to become more engaged in our party. Like many Democrats in San Francisco who love living here because of its open culture, celebration of diversity and progressive social policies, I decided to be bold, and get more involved locally, to work with Democrats and others, to continue to build a City and County that celebrates diversity of all kinds, sexual, racial, ethnic, economic, and age. 3. Potrero Hill Democratic Club endorses fiscally responsible and socially progressive candidates. Please give examples of why you fit these criteria.

In the past I have supported issues that I found to be fair and prudent without creating too much of a fiscal strain on the City or on items that would become mandated obligations that provided little or no flexibility to the Board of Supervisors or the Mayor. Our civic leaders need choices when tax revenue sources change or unforeseen costs are encountered. In previous elections I voted for Measure A and C in the November 2009 election. Given the City's current fiscal crisis, voting for mandated social progressive measures, we may have wanted to reconsider them. I also believe that vibrant City is comprised of a mixed economic community and we need to support housing policies that support this diversity which includes the middle class and families.
