1. Why are you running for office?

As the son of a family transformed by education, a reformer and a Board Member, my work has been guided by a core belief that everyone deserves a fair chance to a quality education, and that our City and economy's potential can only be as strong as our schools and colleges.

2. What are your qualifications for this position? If you are an incumbent, describe your major accomplishments while in office.

My commitment to the education and civil rights is rooted from my family's refugee experience. Their struggle for a better life has motivated me to continually fight to ensure the American Dream remains vibrant and within reach for all of our citizens. I have focused on improving college completion opportunities for all students, improving programs for English Language Learners, pressing for greater efficiencies in the financial aid office, expanding district-wide work study programs, and created a revolving fund for veterans, which provides temporary aid for housing, books, and fees.

3. The Accrediting Commission has detailed the following concerns for San Francisco City College: deficit spending; too much of budget going to salaries and benefits; too few administrators for size of school; failure to conduct financial audits. If elected, what solutions to these problems would you as Trustee pursue? (Please answer in  $\leq$ 300 words)

The sole mission of any trustee will be to ensure that the college remains accredited. In seeking to remain accredited, the Accrediting Commission has outlined a clear path to fixing long-standing problems that should have been addressed since the 1990s. From the moment I took office just over three years ago, I fought for basic fiscal safeguards, systemic reform, and the exact changes we are now called upon to make – improving operations, ensuring greater accountability and smarter spending.

Specifically, the major challenges are (1) addressing entrenched internal governance structures (2) administrative restructuring and (3) spending our money better – whether it be addressing our \$180 million plus retiree health obligation, use of reassign or other non-instructional time, or smarter enrollment management, for example.
