1. Why are you running for the DCCC and what do you hope to accomplish if elected or re-elected? I'm running because the DCCC has been absent on issues that affect low-income, the poor and working class San Franciscans. I will work to make the DCCC an advocate for those who are being forced to flee our city by ever increasing housing costs, this is especially true for students. While not being able to write and enact legislation, the DCCC can be a strong advocate in influencing legislation and work with progressives to shape public opinion.

2. Please describe your current and past community activism. As a student I was one of the leaders in the historic student strike at SF State that led to the establishment of Ethnic Studies and increased enrollment of minority students, Worked with leaders in the Western Addition to file suit against HUD over relocation rights. we won the case that went to the Supreme Court, and established citizen Participation in the redevelopment process, the first in the nation. last four years worked to assist veterans gain employment, currently heading veterans assistance committee for local NAACP.

3. Would you support closing the campaign finance loophole that allows candidates running for their party's Central Committee to raise unlimited funds, while other candidates for local

elected office are limited to \$500 per donor? Why or why not? yes. current loophole allows current office holders for other office to double-dip, giving them unfair advantage.

- Proposition G (2014), Additional Transfer Tax on Residential Property Sold Within 5 Years of Purchase

 - Supported Opposed Why? unregulated short-Term Rentals disrupt neighborhoods and can force the unfair ejection of low-income tenants.
