## Potrero Hill Democratic Club April 5, 2016 Meeting Minutes

President Joni Eisen called the meeting to order at 7:14 PM.

The minutes from the previous meeting were approved and, after an audience member requested time to make an announcement, the evening's agenda was approved.

Lander Karath and Todd May, chief medical officer at SFGH, presented the pro position for Proposition A - Public Health and Safety Bond. Since the ballot argument con position was not yet available, PHDC officer JR Eppler asked pointed questions for clarification on issues of service to Lander and Dr. May. The audience then asked more questions regarding improvements in care and access.

PHDC officer Bob Boileau presented a brief summary and his opinion of Proposition B - Park, Recreation and Open Space Fund - which was to suggest that the Recreation and Park department should not be allowed a blank check for spending.

At 7:41 pm, the judicial candidates for Superior Court Judge, Office 7, Paul Henderson, Victor Hwang, and Sigrid Irias, gathered for a panel, moderated by PHDC officer Eppler, followed by audience questions.

Susan Pfeifer and Gustav Feldman spoke on behalf of Democrats Hillary Clinton and Bernie Sanders for U.S. President, followed by moderated questions from PHDC officer Tony Kelly, then with questions from the audience.

PHDC officer Kelly presented a summary of Proposition C, Affordable Housing Requirements, a charter amendment, fielded audience questions and made his recommendation to the club to vote yes.

President Eisen presented a summary of Proposition D, Office of Citizen Complaints Investigation, an initiative ordinance, fielded questions from the audience and made her recommendation to the club to vote yes.

PHDC officer Audrey Cortes presented a summary of Proposition E, Paid Sick Leave, an initiative ordinance, fielded questions from the audience and made her recommendation to the club to vote yes.

PHDC officer Kim Christenson, presented a summary of Measure AA, SF Bay Clean Water, Pollution Prevention and Habitat Restoration, a district measure, fielded questions from the audience and made her recommendation to the club to vote yes.

President Eisen presented a summary of Proposition 50, Members of the Legislature: Suspension, a CA legislative constitutional amendment, fielded questions from the audience and made her recommendation to the club to vote yes.

President Eisen adjourned the meeting at 9:22 pm. Ballots were turned in by eligible voting members and counted by immediately by PHDC officers. PHDC Tech Officer John O'Neill posted the results to the club's Facebook page.
